10.1 **WFKH** wedi derbyn cwynion ynglyn a baw ci ym Mhorth Swtan. Y clerck i gysylltu a CSYM. *WFKH received complaints regarding dog fouling at Porth Swtan. The clerk to contact IOACC.*

10.2 **ED** yn mynegi pryder ynglyn a chyflwr y lon drwy Llanrhuddlad tuag at Llanfaethlu, ynghyd a mieri sydd angen eu torri rhag achosi problemau parcio. *ED expressing concern regarding the condition of the road through Llanrhuddlad towards Llanfaethlu, as well as the need to cut some hedgerows which could cause a parking obstruction. The clerk to contact IOACC.*
