4.1 Y cleric wedi cysylltu a'r twrna sy'n trosglwyddo y gof golofn i fynegi pryder ynglyn a'r amser wedi pasio. Clo newydd yn amharu a'r gwaith unwaith eto. *The clerk had contacted the solicitors facilitating the transfer of the war memorial to express concern regarding the time lapsed. The current lockdown has again caused a delay.*

6.1 Derbyniwyd lythyr gan CSYM ynglyn a cau lon ger Cerrig Diamwnd dros dro. *Notice received from IOACC regarding temporary closure of the road near Cerrig Diamwnd.*

6.2 Llythyr gan CSYM yn nodi gor dyfiant ar un o'r llwybrau cyhoeddus ger Orsedd Goch/Clegir. Y cleric i wirio os yw'n un o'r llwybrau sydd wedi ei gcontractio i'w dorri. *A letter was received from IOACC regarding some overgrowth which needed cutting on the footpath near Clegir/Orsedd Goch.*
The clerk to check if it's one of the footpaths contracted out to be cut.



6.3 Dim ymateb swyddogol gan y contractwr torri'r parc ynglyn a'r bil gafodd ei wirio, ond yn dilyn sgwrs anffurfiol gyda un o'r cyngorwyr cadarnhaodd nad oedd wedi bod yn ei dorri fel cytunwyd. *No official reply received from the contractor responsible for cutting the park following a query about the bill, but an informal discussion with a councillor had confirmed the park had not been cut as agreed.*

8.1 Mynegwyd diolch i **HR** am ei waith yn torri'r parc. *Thanks were expressed to HR for his work in cutting the park.*

8.2 **WFKH** (drwy'r clerc) wedi derbyn cwynion ynglyn ac arwydd a gwaith yn Traeth Grugmor. **KH** yn cadarnhau fod y mater dan sylw CSYM. *WFKH (via the clerk) had received complaints regarding a new sign and works undertaken at Traeth Grugmor. KH confirmed the matter was under investigation by IOACC.*

8.3 **JG** yn nodi bydd CSYM yn codi ffi o £35 am gasglu biniau gwyrdd o 2021 – bydd modd cofrestru am y gwasanaeth ar lein o Rhagfyr 2020, ac ar bapur o Ionawr 2021. *JG noted that IOACC will be charging a fee of £35 to empty the green bins from 2021. Registration for the service will take place online from December 2020, and on paper from January 2021.*

8.4 **JG** yn datgan fod gwaith yn parhau gan CSYM i liniaru effaith Covid-19 ar wasanaethau'r cyngor, ac fod staff a gwirfoddolwyr wedi bod yn gweithio yn galed iawn, ac yn arbennig arweinwr y cyngor Llinos Medi Huws a oedd wedi bod yn gweithio yn ddi flino dros y misoedd diwethaf.

JG noted that work was continuing by IOACC to mitigate the impact of Covid-19 on services, and staff and volunteers are working hard, in particular council leader Llinos Medi Huws who has worked tirelessly over the last few months.
