Cofnodion Cyfarfod Cyngor Bro Cylch y Garn a gynhaliwyd Nos Fawrth, 23 Tachwedd 2021.

1. Croeso ac ymddiheuriadau. *Welcome and receiving of apologies.*

3. Arwyddo Cofnodion *Signing of Minutes*

Derbyniwyd cofnodion Hydref 2021 fel rhai cywir / *The minutes of October 2021 were accepted as correct.*

4.1 CSYM wedi ymateb i gadarnhau y byddent yn erdych ar gwelliannau i doiledau Porth Swtan eleni. *IOACC confirming they will be looking at improvements to the toilets in Porth Swtan this year.*

4.2 Y clerc yn cadarnhau fod ceisiadau wedi ei gwenuid unwaith eto i adran briffyrdd i wneud ymweliad safle i drafod y problemau parcio yn Llanfairynghornwy a Llanrhuddlad, ond dim ymateb. *The clerk confirming the highways department had been contacted again to request a site visit to discuss the parking issues in Llanfairynghornwy and Llanrhuddlad, but no response had been received.*

5. Deddf Cynllunio Gwlad a Thref *Town & Country Planning Act.*

5.1 Cais llawn ar gyfer codi adeilad pwll nofio yn / *Full application for the erection of a swimming pool building at Cae Bach Eithin, Llanrhuddlad. Dim sylwadau/ No comments.*

5.2 Newid defnydd ac atgyweirio Bryn Glas, Llanrhuddlad / *Change of use and refurbishment Bryn Glas, Llanrhuddlad.*

Nodwyd yr effaith negyddol ar y sefyllfa priffyrdd yn y pentref, ond y gallai hyn fod yn gyfle i ddatrys y broblem yn y tymor hir wrth sicrhau fod gwelliannau a buddiannau cymunedol o'r datblygiad. Y Cyngor yn cytuno i gefnogi'r cais ar yr amod y byddai buddiannau cymunedol sylweddol yn dilyn. *It was noted there could be a negative effect on the already problematic highways situation in the village, but that this could be an opportunity to solve the issue in the longterm by ensuring there would be improvements as a result of the development. The council agreed to support the development on the condition that significant community gains, in particular in the highways issue would follow.*

6.1 Llythyr gan Un Llais Cymru yn nodi'r angen i'r Cyngor Cymuned ddarparu gwasanaeth sy'n galluogi cynghorwyr ac aelodau o'r cyhoedd i ymuno ar lein. It was noted there was no internet connection at the hall in Llanfairynghornwy or Bethel Hen, and so it was decided by the council not to action this for now, and wait to see how other councils prepared this service.*
